

## **RULES FOR CAMPERS**

- All persons must check-in/register at the camp office. (Camps put on by Circle Six will have check-in/registration in the office as well)
- Campers must indicate what medications they will use at camp. All medications are to be listed on the Registration
  Form and taken to the Health Center and registered with Circle Six medical staff. All medications MUST BE in the
  original bottle and/or container.
- Medications will be administered as per RX label instructions and dosage, unless written, signed, and dated
  parental instructions state otherwise. ALL MEDICATIONS REQUIRE A COMPLETED MEDICATION
  ADMINISTRATION FORM (printable from the website). All campers are prohibited from sharing any medication,
  including over the counter medications.
- Campers who are ill or injured must be either in the Circle Six Office, Health Center, or hospital. In the event of
  illness or injury, students will not be permitted to remain in their dorm rooms. Campers may return to normal
  camp activities once they have been cleared by the Camp Nurse.
- Phone Policy for STUDENTS: Students are NOT allowed to possess cell phones at camp. "Possess" means carry on their person, keep in their luggage, or otherwise have access to without the supervision or a sponsor.
- Please respect all camp properties. We ask you to assist in keeping the grounds clean of trash. Cans are provided camp wide to contain debris. There will be fees for damages and excessively dirty cabins.
- No pets allowed. Please DO NOT TOUCH THE WILDLIFE.
- Illegal drugs, alcohol, knives, ANY form of tobacco, Zyn pouches, vaping devices, guns, skateboards, fireworks, and prank supplies are not permitted. Such items will be confiscated.
- No use of the Challenge Course or pool is allowed unless Circle Six authorized, trained, personnel are present.
- Shoes must be worn at all times (unless a camper is in the pool).
- Closed toe shoes are required at our recreation locations.
- Modest clothing required. No spagnetti straps, short shorts, two-piece swimsuits, or monokini style suits allowed. Staff has full discretion to request a camper change clothes.
- PDA will not be tolerated (public or private).
- Campers are not allowed to enter dorms of campers of the opposite sex.
- Campers are not allowed to leave the campgrounds while attending camp.
- Campers must be where they are supposed to be when they are supposed to be there.
- Campers must wear name tags at all times.
- Campers are to respect all adult leaders and follow their instructions.



## **Sponsor Specific Rules**

- Texas Youth Camp Law requires two adult sponsors in each dorm room. Sponsors must be at least 18 years old (19 for Youth camp), have a current criminal/sex offender background check, be approved by their church pastor, and have completed Child Protection Training before coming to camp.
- All vehicles must be unloaded immediately upon arrival. After unloading, all vehicles must be parked at the hotel
  parking lot. If you need a way to get around camp, we have a limited number of golf carts available to rent out. If
  you rent a golf cart, please refer to the rental agreement for rules and regulations.
- ABSOLUTELY NO OUTSIDE GOLF CARTS OR ATVS WILL BE PERMITTED ON CAMP.
- Circle Six allows visitors to camp, but STRICTLY ENFORCES THE FOLLOWING PROTOCOL TO KEEP CAMPERS SAFE:
  - ALL VISITORS must stop first at the camp office to sign in.
  - ALL VISITORS must show valid identification (driver's license), and allow camp staff to make a photocopy.
  - ALL VISITORS must allow camp staff to photograph their vehicle's license plate.
  - ALL VISITORS MUST WEAR A GUEST NAME TAG.
  - ALL VISITORS are prohibited from being alone with campers.
  - ALL VISITORS must stop by the office on their way out to sign out.
- The front gate will be closed nightly from dinner through breakfast.
- It is your responsibility to make sure your students are taking their medications.
- Please contact us for any maintenance needs throughout the week.
- We require a 1:8 ration for all of our camps (1 adult for every 8 students). You need to bring your own sponsors or make arrangements prior to coming to camp. THE CHURCH ATTENDING CAMP IS RESPONSIBLE FOR FINDING SPONSORS.
- Cell Phone Policy for SPONSORS: Sponsors must not allow cell phones to distract others or themselves from the camp program. Phone usage must be limited to only absolutely necessary calls, messages, internet activity while at camp. Adults may use phones for note-taking, Bible reading & appropriate image capturing while at camp.
- Sponsors. Each youth camp shall have at least one adult sponsor who is responsible for the supervision of no more than ten children in the camp. For any youth camp specialized activity, the sponsor(s) shall be in the immediate vicinity (within sight and/or hearing) of the campers. An "all camp" sedentary activity, not requiring physical activity must have at least one adult sponsor to every 25 campers.
